Other: Main clinical question/concern (Owner does not want to send to the OFA experts and desires an IDEXX opinion as to how the hips should be scored instead.), Additional information (), Additional medically pertinent information (The name is wrong on the images. The dog's name is Violet, not Jasmine. That cannot be corrected after rads are taken.)

PELVIS AND ELBOWS May 2, 2023: A flexed lateral view of each elbow and a VD view of the pelvis is provided for evaluation. As mentioned in the history the images are identified as Jasmine Love however the patient is listed as Violet Love.

COMPARISON: None available.

FINDINGS: ELBOWS: The margins of the elbow joints are normal bilaterally. No degenerative changes or abnormalities associated with the anconeal process. The medial coronoid process appears to be normal. The included long bones are normal.

PELVIS: There is adequate coverage of the right femoral head by the acetabulum. There is approximately 50% coverage of the left which is considered adequate. No degenerative changes with either of the coxofemoral joints. The included pelvic limbs, abdomen and vertebra appear to be normal.

CONCLUSIONS: Unremarkable radiographs of the elbows and pelvis.

RECOMMENDATIONS: Orthogonal radiographs could be considered for further evaluation.
